EXTRACT FROM THE "REGULATION ON PREVENTION AND CONTAINMENT MEASURES FOR THE SPREAD OF SARS-COV-2"

Art. 2 - Responsible parties and general information

4. Families are required to sign and respect the content of the renewed Educational Pact of Co-Responsibility. In order to early identify every possible case of contagion and contribute to the development of the students' sense of responsibility, it is mandatory to verify systematically and on a daily basis the students' health condition.

Art. 4 - General Rules

- 1. Students' prerequisits to attend school and classes are:
- a) absence of respiratory symptoms or body temperature above 37.5 C in the previous three days;
- b) not having been in quarantine or home isolation in the last 14 days;
- c) not having been in contact with positive people (as far as known) in the last 14 days.

Art. 5 - Rules and Regulations for school arrival

- 1. It is forbidden to enter the school in the case of temperature above 37.5 C or COVID-19 compatible symptoms. In this case, it is necessary to stay at home and telephone the pediatrician, the medical guard or the Regional Health Hotline.
- 2. it is mandatory wearing the mask to access to the school building.
- 3. access to the school building is forbidden to anyone who, in the last 14 days, has had close contacts with positive to SARS-Cov-2 people or people coming from at risk areas.
- 4. students who had positive results at SARS-Cov-2 are allowed to attend school, but the attendance must be preceded by hand delivery (in a closed envelope addressed to the School Manager) of medical certification, issued by the Department of Territorial Prevention. The medical document certifies that the compulsory swab is negative: the documentation itself will be managed by the school staff according to the PRIVACY policy.
- 8. it is mandatory for students' families:
- contact the secretarial offices by e-mail or telephone contact, in order to avoid all not-strictly-necessary access;
- use, whenever possible, remote communication tools (such as telephone, e-mail, PEC, etc.);
- comunicate to the School Manager or the Teaching Office any case of proven and documented SARS-Cov-2 positivity of their children: this is to allow monitoring and tracing of close contacts in conjunction with the local prevention department, and to early identify any possible other cases.

Art. 6 - The role of schools, students and their families

- 2. The school is provided with infrared thermometers and school staff may use them in every moment to take the temperature both in dubious situations and in a programmed moments;
- 5. both individual and collective in-presence parents/teachers meetings are suspended for the entire 2020/2021 school year, except for cases of particular urgency and gravity, at the request of the School Manager and/or of the teachers. Parents/teachers meetings will be held by videoconference at the request of the parents: the request is to be forwarded via online register;
- 6. families are not allowed to bring any food, school or other material during the morning to students engaged in school activities. Any access to school buildings must be requested by school staff, or programmed by contacting the secretarial offices via mail or telephone.

Art. 7 - Subdivision of school buildings into sectors; transits during activities

- 1. Students and their classes will use proper channels for any access operation: all the channels are indicated by appropriate horizontal and vertical signs
- 4. students will stay in their classroom, sitting at their place and wearing the mask during the breaks. If distance can be maintained, students can stay in dedicated corridors/lounges/spaces under the supervision of teachers. Students are allowed to remove their mask only for the time necessary to consume snacks or to drink.

Art. 8 – Access and exit operations

- 1. Parents of kindergarten, primary and secondary school of first degree students will scrupulously respect the times of access and exit, and will as well maintain social distance to avoid gatherings: families will also ensure that their children wear the mask correctly.
- Teachers and families of secondary school of first degree students will make children aware of the use of protective equipment and the respect of distance rules. Parents are invited, compatibly with the arrival times of public transport, to avoid early arrivals in order to reduce waiting time and resultant gatherings;
- 2. students will reach their classrooms fastly and orderly, in the expected time, respecting the physical distance. It is not allowed to linger in the spaces outside the buildings. Students arriving late or at the changing lesson time will enter the main entrance and go directly to their class;
- 3. once in the classroom, students will take their seats without taking off their mask. During the access operations, students are not allowed to linger in corridors and other common areas and, once in the classroom, are not allowed to leave their seat.

Art. 9 - Prevention measures during school hours and educational activities

1. Students are required to maintain interpersonal physical distance between them during teaching activities: at least 1 metre in classrooms, laboratories, other educational environments and at least 2 metres in gyms.

Art. 10 - Access to toilets

- 1. Whoever wishing to access the toilets is placed in a neat and spaced row, wearing the mask; it is mandatory to wash hands with soap and water before entering the room;
- 2. Whoever access the toilets takes care to leave the room in order; it is mandatory to disinfect hands with sanitizing gel before entering the room and, then, wash hands with soap and water.

Art. 12 - Personal hygiene precautions

- 2. Soap dispensers are placed in the toilets for proper hand washing; in addition, sanitizing gel dispensers are placed at the entrance of each classroom, in the main rooms, near the entrances and exits:
- 3. It is suggested to bring to school a bottle of sanitizing gel and handkerchiefs for strictly personal use:
- 4. Students are not allowed to exchange each other neither school materials (such as books, exercise books, pens, pencils, drawing equipment) nor personal effects (toys, money, electronic devices, clothes etc.)

Art. 14 - Management of symptomatic persons within the School Institute

- 1. In case a student at school manifests fever or COVID-19 compatible symptoms in school, s/he must be immediately accompanied in a dedicated school room;
- 2. School staff convenes a parent, a person of legal age delegated by the parents or those who exercise parental responsibility, who must **forthwith** go to school to take back the student (**it is therefore of utmost importance to provide the school with up-to-date contact details to be contacted**). School must as well notify the competent health authorities or emergency numbers for COVID-19 provided by the Region and/or the Ministry of Health.

Art. 15 – Protecting the health of medically fragile workers and students

4. Medically fragile students are subjects exposed to a potentially increased risk to the COVID-19 infection. The specific situations of fragile students are to be evaluated in conjunction with the Department of Territorial Prevention and the pediatrician/general family practitioner. It is mandatory for families to communicate to the school peculiar medical conditions in written, documented forms.
